FAMILIARISATION PROGRAMME CONDUCTED FOR INDEPENDENT DIRECTORS OF THE COMPANY

As part of the effort to familiarize the Independent Directors of the Company about the roles, responsibilities, duties and obligations of Independent Directors the presentations made to the Independent Directors are given in Chronological Order

1. October 21, 2016 : A presentation was made by Mr S N Ananthasubramanian, Former President of ICSI, Practising Company Secretary, Sage Governance Advisory LLP covering inter alia:
 - a. Actionable requirements on Corporate Governance under the Companies Act and SEBI Regulations;
 - b. Role, Responsibilities, Duties & Obligations of Independent Directors under the Companies Act and SEBI Regulations;
 - c. Policies to be framed by the Company under the Companies Act and SEBI Regulations;
 - d. Website Disclosures and Annual disclosures to be made by the Company;
2. July 27, 2017 : A presentation was made by NPCI (National Payments Corporation of India) Team on role of NPCI in development of digital banking in India as part of familiarisation programme for Directors.
3. January 31, 2018 : A presentation was made by M/s S R Batliboi & Associates LLP, Statutory Auditors of the Company on Ind-AS highlighting the key principles and accounting implications under the same.
4. January 31, 2018 : A presentation on salient features of Companies (Amendment) Act, 2017 highlighting the major changes concerning Directors, Company and such other changes on disclosure/procedural requirements etc., were made to the Board.
5. November 2, 2018 : A presentation on “Principles governing disclosures and obligations of listed entity under SEBI LODR Regulations” was made by Mr P H Arvinth Pandian, Senior Advocate and Additional Advocate General of Tamil Nadu to the Board.

The above were in addition to the following familiarization programme carried out by the Company on an on-going basis.

- a. **Induction Programme:** The Company issues a formal letter of appointment to the Independent Directors which incorporates all relevant information about the appointment, roles, duties and responsibilities of Independent Directors including the terms and conditions of their appointment. A copy of Schedule IV to the Companies Act, 2013 which contains guidelines for professional conduct, role and functions of Independent Directors, their duties etc., and the Company’s Code of Conduct for the Directors are shared with the Directors for their information and adherence on an on-going basis. A copy of Memorandum and Articles of Association and latest Annual Report of the Company are also given to the Directors to familiarize them with the Company’s background.

The Company conducts an introductory familiarization programme / presentation, when an Independent Director joins the Board of the Company. Field visits are organized for the Directors to enable them to understand and familiarise with the operations of the Company and its Subsidiaries;

- b. **Quarterly updates/Presentations on Operations:** The Independent Directors have complete access to senior management and information about the Company. Presentations are regularly made at the meetings of the Board and other Committees constituted by the Board, where the Independent Directors get an opportunity to interact with the senior management. Further, there is a detailed presentation on business plan, operations and performance of the Company and its Subsidiaries, industry comparison, etc.
- c. **Regulatory updates:** Periodical regulatory updates impacting the business which helps the director familiarise himself with theregulatory framework in which the Company operates are circulated and discussed.
